In July 2002, NADA Germany was founded with a festive act in the Old City Hall of Bonn and was recognised by the foundation supervisory authority on the 21st of November in the same year. Since then, it has been pursuing its valuable mission and supports athletes who pursue their sport with integrity. As a non-profit foundation under public law, which has been institutionally supported since January 2020, NADA Germany is an independent body. NADA Germany opposes doping in sports nationally and internationally alike. For the future of sport. For Germany as a sport nation. For clean athletes, for transparent success and honest results.

# FOR CLEAN SPORT DURING THE COVID-19 PANDEMIC

In the spring of 2020, NADA Germany was forced to pause the regular testing programme for just under two months as a result of the COVID-19 pandemic. Nonetheless, the anti-doping work continued running at a high standard during this time. NADA Germany worked towards innovative solutions to support clean athletes.

Among other projects, the "Dried Blood Spot" method was initiated together with athletes to further develop the testing programme and to meet future requirements. To reveal possible doping violations during the lockdown, NADA Germany strengthened the Intelligence and Investigations work. After resumption of the regular testing programme, various analytical methods were used in order to detect any possible deviations during the lockdown. The prevention department created a large online offering to continue the educational work. The usage of the e-learning course has increased during the pandemic and workshops are

offered digitally. An important focus in 2020 was the constant exchange with colleagues from all over the world. The success and further development of future anti-doping working depends on this exchange of experience and specialist discussions. The financing of NADA Germany is the basis for the realisation of all activities. Thanks to the institutional funding by the federal government since January 1st, 2020, NADA Germany has been provided with a secure financial foundation.

# **ANTI-DOPING WORK DURING THE PANDEMIC**

With the rise of the COVID-19 pandemic in the past year new challenges and prospects for NADA Germany's work emerged. In consideration of the ever present risk of infection, sporting events moved into the background for several weeks. The expected sporting highlights of 2020, the Olympic Games and the Paralympics in Tokyo, were postponed for one year, and numerous competitions in Germany had to be canceled.

Although different and reduced in some areas, the anti-doping work was ongoing throughout the year. A major milestone for NADA Germany was the implementation of the revised World Anti-Doping Code 2021 into the NADC21 and the official recognition as one of the first anti-doping organisations worldwide to be compliant. NADA Germany thus continues to meet the requirements of WADA's regulations.

The two main pillars of NADA Germany's work are doping prevention and the testing programme. New and partly digital practices were developed within these fields, in order to continue the important work for clean sport during the COVID-19 pandemic. The work of NADA Germany significantly contributed to the pandemic-related restricted equal opportunity in sports in 2020.

In 2020, NADA Germany supported athletes and their athletic environment with the prevention program TOGETHER AGAINST DOPING primarily by virtual methods for clean performance. The already existing network structure was used to implement the online education programme for various target groups.

The testing programme had to be suspended to a large extent for several weeks due to the COVID-19 pandemic. The department used this opportunity to develop new methods to carry out tests. The pilot project "Dried Blood Spot" is one of the innovative projects for the anti-doping work of the future. As sport events resumed, NADA Germany implemented extensive security precautions for infection prevention of SARS-CoV-2 for all parties involved in the testing process. These are still part of the testing process standard today and are constantly adapted to current developments.

It is essential for international equal opportunity that also in times in which competitions are not possible, that anti-doping work continues. The social importance of sport and its role model effect requires commitment for fairness and transparency, even in a difficult environment.

The members of the Supervisory Board accompanied NADA Germany in 2020 and continue to ensure that the successful work of the foundation can be carried on and expanded.

# **TESTING PROGRAMME**



Pilot project "Dried Blood Spot (DBS)"

## COVID-19: The impact on the testing programme and "Dried Blood Spot"

NADA Germany had to suspend its classical testing programme between March and May. Anti-doping work continued in all areas, including the testing programme, despite the lack of urine and blood controls during the first lockdown of spring 2020. Following the announcement of the postponement of the Tokyo Olympic Games to 2021, NADA Germany's testing programme was adapted accordingly. NADA Germany's testing programme department also worked towards innovative solutions and initiated the "Dried Blood Spot (DBS)" method. Athletes were sent DBS-test-kits with which they were able to collect a small amount of blood themselves. The collection took place unannounced after a call from NADA Germany and was accompanied by a employee via live video transmission. NADA Germany used this opportunity to collaborate with athlete volunteers in a scientific project. Together, NADA Germany and athletes worked at enhancing the testing programme so that it can meet the demands of the future. From NADA Germany's perspective, the DBS-test represents an innovative alternative that could also be used for future

anti-doping work, given that the analysis of the blood drop is anchored into international regulations. Several athletes participated in the pilot project, among them candidates for the Tokyo Olympics 2020.

NADA Germany resumed classic doping controls in training and competition in mid-May 2020 with appropriate safety precautions to prevent infection. The first doping controls were carried out for Germany's Bundesliga and 2nd Bundesliga in football. The established hygiene standards include being symptom-free for at least 14 days prior, mandatory medical grade respiratory masks for the testing staff, and the use of disinfectants. The hygiene measures were updated continuously so that, in the course, mandatory rapid and PCR tests were implemented for the testing staff. During the implementation of the testing programme, NADA Germany takes the recommendations by WADA into account and follows the instructions given by the Robert Koch Insitute.

#### International exchange

Despite the worldwide restrictions, NADA Germany remained in contact with international experts in testing planning and implementation from other leading NADOs by monthly video calls. Thereby, significant contributions could be made to the testing hygiene guidelines published by WADA. In addition, the regular exchange provided valuable tips and opportunity for discussion regarding the implementation of the international testing programme during the COVID-19 pandemic. Furthermore, NADA Germany presented its digital testing system with the implementation of the DBS-test to an international audience with designated anti-doping experts at the Science Symposium of the U.S. Anti-Doping Agency (USADA) in the fall.

#### Evaluation of "Pain Medication"

NADA Germany evaluated 8,344 doping control forms from doping controls, which were carried out by NADA Germany in five football seasons between 2015/16 and 2019/20. These were doping controls inside and outside of competitions in Germany's Bundesliga, 2nd Bundesliga, 3rd division, women's Bundesliga, A and B junior Bundesliga as well as in the cup. The evaluation was published in March 2021 in the German Magazine for Sports Medicine (Deutsche Zeitschrift für Sportmedizin).1

## Project re-analysis of long-term stored samples of German top athletes

NADA Germany developed a separate re-analysis programme for selected long-term stored samples in cooperation with the WADA-accredited laboratory Institute of Biochemistry in Cologne based on the findings by "Operation Aderlass". As part of the project, 50 urine samples and 58 serum samples were reanalyzed. The samples included potential Olympic Games participants in Tokyo 2021 and Beijing 2022.

# LEGAL MATTERS

#### National Anti-Doping Code 2021

The National Anti-Doping Code (NADC21) and the associated standards and athlete rights of NADA Germany, which is based on the World Anti-Doping Code, entered into force on January 1st 2021. The NADC21 represents the most important overarching anti-doping regulations for all sport disciplines. It implements the essential provisions of the WADC 2021 and forms the uniform basis for anti-doping work in Germany.

WADA officially recognised the English version of NADC21 at the end of August 2020. NADA Germany implemented the requirements of the revised WADC 2021 in the national regulations at an early stage and was declared compliant by WADA in summer 2020. In terms of content, the revised Code has resulted in a large number of reforms. A further doping offense has been introduced. Any act with the purpose of intimidating, threatening, or preventing a person from reporting anti-doping rule violations to appropriate organisations will be sanctionable as an anti-doping rule violation.

In addition, WADA's Prohibited List will contain substances that are classified as "substances of abuse" (including narcotics and intoxicants) and which can result in a milder penalty in sanction decisions. With the new categorisation of "recreational athletes", athletes at the lower level have been taken into account since January 2021. The term "protected persons" includes all athletes, regardless of age - with the exception of 16 and 17-year-old elite athletes and all disabled athletes - who are not (fully) legally competent under applicable national law.



## Standard for results management and disciplinary proceedings

The central reform of the NADC21 is the modification of the results management and disciplinary proceedings. Based on an international harmonisation of the procedures of disciplinary proceedings, the procedures of national sanction proceedings - for example before the German Court of Arbitration for Sport (DIS) - have been revised and adapted. The standard also includes results management for the Athlete Biological Passport and regulations on reporting obligations and failures to report and missed tests. Appendix B of the standard for results management and disciplinary proceedings replaces the previous standard for NADA Germany's reporting obligations.

#### Standard for doping prevention

Finally, the importance of prevention work is emphasised. A separate standard for doping prevention contributes significantly to the worldwide improvement of information and awareness-raising work. A values-based approach is the basis of future prevention work since January 2021. The standard regulates the responsibility and implementation of doping

prevention programmes and describes the content-related components.

With the national prevention programme TOGETHER AGAINST DOPING (GEMEIN-SAM GEGEN DOPING), NADA Germany has been placing a clear focus on preventive measures for many years.

To implement the new Code, all national sports associations and national stakeholders had to recognise the NADC21. For this purpose, NADA Germany provided the German version of the NADC21 and a sample anti-doping code as an implementation aid in autumn 2020. In addition, NADA Germany organised several information events for anti-doping officers and athletes – in digital form, due to the COVID-19 pandemic.

The WADC 2021 and NADC21 became valid on January 1st, 2021 and since then replaces the previous code from 2015.

#### "Operation Aderlass"

Based on the findings of "Operation Aderlass", NADA Germany continued high-level investigating in 2020.

Two sports law proceedings had been initiated in Germany by the time of going to press. One of these proceedings is pending before the international Court of Arbitration for Sport (CAS).

NADA Germany continues to cooperate with its partners in Austria and Switzerland for the processing of the events.

#### NADA Germany's publication practice

NADA Germany is in contact with the North Rhine-Westphalia state data protection officer responsible for the foundation (LDI NRW) regarding the lawful publication practice of sanction

decisions from doping proceedings. According to the preliminary assessment of the LDI NRW, the publication of personal information and arbitration awards from disciplinary proceedings on the Internet in the manner previously carried out by NADA Germany is not permitted. According to LDI NRW, there is no valid legal basis for this type of publication. The comprehensive review procedure of the LDI NRW has not been completed yet. Until the final decision, NADA Germany will not publish any sanction decisions in its online database. The responsible authorities with a legitimate interest in the sanction decisions will continue to be informed promptly and comprehensively with the results of the sanction decisions in

accordance with the WADC. In addition, NADA Germany will continue to publish its own press releases with facts on cases that are already publicly known.

In 2020, 35 results management proceedings were initiated due to possible anti-doping rule violations. So far, NADA Germany has initiated disciplinary proceedings before the DIS in two cases. NADA Germany also concluded eight arbitration proceedings before the DIS from the previous year and conducted seven further proceedings before the CAS.

# INTELLIGENCE & INVESTIGATIONS



#### Strengthening the I&I work

The Intelligence & Investigation work (abbr.: I&I) came into focus in the first lockdown in 2020, in particular through the suspension of classic doping controls. The I&I team continued investigations during the COVID-19 pandemic, stepped up the general professional monitoring, also in cooperation with Sportradar, and followed up on all reports received by NADA Germany via the whistleblower system "SPEAK UP" (SPRICH'S AN).

The cooperation with the public prosecutor's offices and at international level has shown how important networking is in the area of investigations. Information, which in some cases converged in the I&I team over months and years, successfully led to the initiation of proceedings in 2020. The cooperation with Sportradar took place in 2020 in strict compliance with data protection requirements, especially in the areas of social media monitoring and analysis, due diligence & risk and compliance analysis as well as network research and case analysis. Sportradar supported NADA Germany by investigating possible doping violations and following up whistleblower reports. In the past year, 22 circumstances were

examined more intensively and additional information was gained on individual cases. Due to the COVID-19 pandemic in 2020, a lack of contacts and a lack of competitions, the number of reports declined for the first time.

#### Digital exchange with government investigative authorities

In May 2020, the annual exchange of NADA Germany with the state investigative authorities and the WADA-accredited laboratories took place as a virtual event for the first time, due to the difficult global conditions. 25 representatives from public prosecutors' offices from Germany and Switzerland, the Federal Criminal Police Office, the State Criminal Police Office, the Customs Criminal Police Office and the Swiss Federal Police as well as colleagues from Antidoping Switzerland and NADA Austria exchanged information with the experts from NADA Germany and the two German WADA-accredited experts Laboratories in Cologne and Kreischa as part of a video conference. The effects of the COVID-19 pandemic were in the forefront in an update by NADA Germany, which it offered digitally to 45 representatives of state investigative bodies in fall 2020. During the virtual meeting, NADA

Germany presented the new NADC21, gave an update on the testing programme and current medical topics and explained its increased I&I work during the lockdown. Current topics from the WADA-accredited laboratories as well as contributions from the customs investigation office and the public prosecutor's offices from Freiburg and Munich rounded off the two-hour session.

#### A global network

International networking is an important component of the I&I work. The joint meeting of WADA, seven other national anti-doping organisations, two international associations and INTERPOL in Bonn 2019 drove the formation of new working groups in this area, which were formed in 2020. NADA Germany is also part of these new I&I groups.

#### Range of information

Even during the rate of infection with SARS-CoV-2, the Medical department was available during telephone consultation hours from Monday to Friday for athletes, physicians, pharmacists, physiotherapists and other support staff for athletes and answered a total of 579 inquiries on 875 medical products. The department also published the German translation of the WADA 2021 Prohibited List, the "Sample List of Permitted Drugs" and the "MediCard".

The Medical department provides the NADAmed database, a comprehensive online research tool in which several thousand drugs and active ingredients can be checked for their doping relevance. Corona vaccine and COVID-19 vaccination have been added as search terms. For training purposes, NADA Germany's Medical department has offered an e-learning course for physicians. In the future, this course will be replaced by WADA's global Anti-Doping

Education and Learning (ADEL). For this purpose, the Medical department translated the English-language WADA e-learning course for physicians and adapted it to German conditions.

Since 2020, the extensive range of information has also included fact sheets on blood, blood plasma, platelet and stem cell donation, which can be accessed on NADA Germany's website. Completing the range are Germanywide lectures, which in last year took place almost exclusively digitally. For example, an online seminar for approximately 350 medical professionals with the title "Sports medicine in top-class sport - anti-doping seminar and COVID-19 pandemic in competitive sport" was organized in cooperation with the German Olympic Sports Confederation.

#### Cooperation in the D-A-CH group

Despite the worldwide restrictions, the Medical department implemented joint projects in the D-A-CH group. The three

organisations worked digitally on the translation of WADA's Therapeutic Use Exemption (TUE) Application Checklists for German-speaking athletes.

# **COMMUNICATIONS & MARKETING**



Digital annual press conference

#### Digital public relations

In 2020, NADA Germany's public relations work was marked by online events, digital meetings and web conversations. Last year, NADA Germany responded to daily press inquiries and provided information to the interested public about its work. The department contributed technical articles for various association magazines and offered several online workshops on various topics to inform media representatives, but also athletes, about current developments and topics. For the first time and over several months, interviews and statements took place almost exclusively digitally due to the COVID-19 pandemic.

The focus of the annual press conference, which was also organised virtually for the first time, was the presentation of the 2019 annual report and the assessment of current anti-doping issues. The journalists' workshop at the beginning of September 2020 dealt with the effects of the COVID-19 pandemic on (international) anti-doping work. All departments provided insights into their work under the difficult global conditions.

The following international experts were present on the virtual podium at the discussion: Nadine Apetz (internationally successful boxer, athlete spokeswoman for the German Boxing Association), Jorge Leyva (Chief Executive Officer, Institute of National Anti-Doping Organisations, INADO), Tom May (Director, Program Development and NADO / RADO Relations, World Anti-Doping Agency, WADA) and the Chairperson of NADA Germany's Executive Board, Dr. Andrea Gotzmann.

#### The initiative for clean sport

# **PREVENTION**



## Prevention measures during the COVID-19 Pandemic

The complexity of the anti-doping issue is not only increasing for athletes, but also for their supportive environment. Holistic anti-doping work requires, in addition to a code and the testing programme, comprehensive preventive measures - especially in times of the COVID-19 pandemic. With TOGETHER AGAINST DOPING (GEMEINSAM GEGEN DOPING), NADA Germany has established a prevention programme to support all parties in organised sport in Germany. The foundation for the implementation of all preventive measures in anti-doping work is the since January 2021 existing International Standard for Education by WADA. It was translated by the Prevention department in 2020, adapted to national circumstances and implemented in a first step. The young athletes form the core target group of the behavioral preventive offers, because effective prevention must start at an early stage in the athletic career. The communication of values is a central element of the educational approach. Ethical decision-making and moral behavior training are at the center of NADA Germany's training courses for young athletes and their environment. However, due to the

COVID-19 pandemic, many face-to-face training courses had to be canceled last year. However, these could largely be carried out digitally or - where possible - postponed to the summer. In order to continue the educational work, the Prevention department expanded the existing, extensive online offer in the past year. The platform www.gemeinsam-gegen-doping.de (together against doping) served as a starting point for anti-doping prevention offers. The e-learning course, which is increasingly being completed in the ongoing pandemic phase, can also be accessed via this URL. In addition, the prevention brochures have been extensively revised and redesigned for all target groups.

In addition to the before mentioned core target group, the offer is also increasingly aimed at the athletes' environment, because this makes a decisive contribution to realising sporting careers with integrity. NADA Germany's prevention programme and, in particular, the attitudes associated with it must be supported and implemented by the sport system. Relational prevention is the key here. It is dedicated to the general conditions in which those who do sports are situated. With the formation of a

network for doping prevention, NADA
Germany addresses the topic of prevention in relationships. At the beginning of 2020, a network event with 70 participants was held in Cologne, and the exchange was then continued digitally in the course of the year. Structures that favor doping can only be identified and targeted through the cooperation of all.

#### Handover of participation app by BISp

The project, which serves to actively involve athletes in doping prevention, was developed on the initiative of BISp in cooperation with NADA Germany and with the participation of Athleten Deutschland e.V. (Amélie Ebert, Board Member of Athleten Deutschland e. V., center in the picture).



#### Digital networking event

Together with BISp, NADA Germany invited representatives from national sports associations, state sports federations and associations, state associations, large clubs and other institutions related to doping prevention for an annual conversation at the beginning of 2021. Due to COVID-19, the TOGETHER AGAINST DOPING network event was held digitally for the first time. The team from the Prevention department of NADA Germany moderated the online conference. The around 100 participants received current information from the field of doping prevention in lectures and discussions.



#### Research project RESPECT

NADA Germany actively participated in the EU research project RESPECT (Research-Embedded Strategic Plan for Anti-Doping Education: Clean Sport Alliance Initiative for Tackling Doping in Sport). RESPECT is a three-year international collaboration between various project partners. The project's objective is to compile findings from scientific research, politics, and practical experience in the implementation of target-oriented projects.

#### **Anti-Doping Officer workshop**

In 2020 the annual exchange organised by NADA Germany for anti-doping officers of the top sport associations took place online. As part of the one and a half hour online workshop, the 45 participants from associations and representatives of the DOSB received an overview of current topics in the individual NADA Germany departments.



#### **Anti-Doping Education & Learning**

Due to the international recognition, NADA Germany is joining WADA's online course ADEL. NADA Germany's Prevention department began translating the individual courses for different target groups in 2020 and is planning to release them in 2021.

# HUMAN RESOURCES, FINANCE & CONTROLLING

## Business performance and and financial position of the foundation

In the fiscal year 2020, the funding that NADA Germany receives was altered to the so-called institutional funding. As part of the institutional funding from the Federal Ministry of the Interior, Building and Home Affairs (BMI), individual projects in the core areas of NADA Germany are no longer subsidised, but rather the NADA Germany Foundation as such.

This new type of funding is a milestone in NADA Germany's financial planning security. Even if the approval period for institutional funding is one calendar year, the donor is in fact committed to funding the institution over many years.

The federal government contributed to NADA Germany's operative business with a grant of around 4,5 million euros. These funds also include the contribution made by the top sports associations funded by the Federal Ministry of the Interior to finance NADA Germany's testing programme. This financial relief for the top sports associations funded by the Federal Ministry of the Interior was decided by the budget committee of the German Bundestag.

The federal states contributed to the financing of doping prevention with a total of 435 thousand euros. Sport contributed approximately 1,7 million euros (reimbursements, grants). The total budget of operations amounted to around 10 million euros. This includes federal funds of around 2,4 million euros, which were passed



on to the WADA-accredited laboratories in Cologne and Kreischa to finance research and analysis.

The global COVID-19 pandemic also had an impact on NADA Germany's business activities. In coordination with the department heads, the works council and the company doctor, the board established extensive COVID-19 infection protection measures (including home office from March 2020). These measures are always based on the current decisions by the federal government and the state government of North Rhine-Westphalia and focused on the specific issues of the foundation. The health protection of the employees as well as all persons involved in the doping control measures and the athlete is always the priority.

#### Human resources

As of 31.12.2020 NADA Germany has 34 full time employees and seven employees in part time, as well as six marginal employees.

NADA's annual financial statements are audited annually by an external auditor. This audit did not lead to any objections for the year 2020.

# INTERNATIONAL COOPERATION

#### Worldwide digital exchange


Working together with other national anti-doping organisations (NADO) is important - even under difficult global conditions, it is important to advocate equal opportunities. The international exchange in 2020 was quickly transferred into a digital format. The focus of many exchanges was the altered conditions caused by the COVID-19 pandemic and the resulting innovative ideas for implementing anti-doping work.

Two NADO Leaders Group meetings took place digitally, at which the current situation of international anti-doping work was discussed and demands for comprehensive system improvements were made. This also occurred in connection with the decision regarding the consequences of the Russian doping scandal.

Another part of this work is the bilateral exchange with individual NADOs. In 2020, this included various digital meetings with the German-speaking anti-doping organisations from Switzerland and Austria at all working levels. Furthermore, the international doping control system expert group exchanged information several times a month via video conference, as well as the communication expert group which increased the number of meetings virtually.

#### International conferences

The International Conference on the Implementation of the revised World Anti-Doping Code was able to take place in Vaals (Netherlands) in January, which NADA Germany also attended. However, all other planned international conferences in 2020 were

postponed, held digitally or canceled. NADA Germany took part virtually in the USADA Science Symposium in September 2020. Stefan Trinks, head of the Testing Programme, presented NADA Germany's digital testing technique in lockdown with the implementation of the "Dried Blood Spot" method.


#### International committees

He is also chairman of the Advisory Group on Legal Issues of the Monitoring Group in the Council of Europe. NADA Germany also took part in the EU-funded RESPECT research project, which is being carried out under the lead of Leeds Beckett University.

# DATA PROTECTION REPORT

Dr. Ralf Schadowski is the responsible external data protection officer.

#### 1. Summary

Hereby I certify the existing data protection management system according to the requirements of the valid Federal Data Protection Act 2018 (new) and the General Data Protection Regulation (EU-DSGVO / GDPR) as an externally appointed data protection officer of the National Anti Doping Agency of Germany.

The National Anti Doping Agency of Germany has undergone an admission based on the BSI Basic Protection and has implemented the recommendations. Specifically the following areas will be implemented in the DSMS data protection management system:

- Order processing according to Art 28 GDPR / §62 BDSG
- Procedural directories according to Art 30 GDPR / §70 BDSG
- Appropriate information procedure according to Art 15 GDPR / §34 BDSG
- Technical organizational measures according to Art 32 GDPR / §64 BDSG
- Privacy policy
- Data protection employee sensitization

#### 2. Status Quo

#### 2.1 NADAius database

NADA Germany's database NADAjus for the administration of sensitive and particularly worth protecting data on the legal basis of the WADC and from it the derived NADC in connection with the Anti-Doping Act did not show any disturbances, conspicuities, erroneous accesses or even data losses in the reporting period. Due to a



data protection complaint proceeding by an athlete at the LDI NRW, the NADAjus database was deleted on 11.11.2020.

#### 2.2 Procedure log

Up to this point, conform to DSGVO Art. 30 procedure directories have been created in the following areas:

- IT
- Administration / secretariat
- · Accounting department
- Office communication / office / writing department

Further process directories are being created. Existing process directories are maintained continuously.

#### 2.3 Fulfilment of information duties

The data protection information for websites and portals has been adapted to the requirements.

#### 2.4 Data deletion policy

Data is deleted or blocked after the legal basis has ceased to exist or after a consent has been revoked, depending on the technical possibilities. Deletion instructions can also be found in the procedural indexes.

#### 2.5 Rights of data subjects

The appropriate information procedure has been prepared, the process has been established and the template for possible requests for information has been drawn up.

#### 2.6 Data security incidents

There were no reportable data protection incidents or IT security incidents in the reporting period. Attack attempts were made, which were always promptly reported to the data protection officer and logged.

#### 2.7 Order processing agreements

All relevant service providers within

the meaning of contract processing pursuant to Art. 28 GDPR were contractually fixed and randomly inspected.

#### 2.8 Technical and organisational measures

The technical and organisational measures pursuant to Art. 32 of the GDPR were examined and approved as a minimum guarantee of compliance with the accountability obligations pursuant to Art. 5 of the GDPR.

#### 3. Providing training

The organisation's management highly values the annual data protection employee sensitisation (BDSG, TKG, EU GDPR) to comply with the accountability obligations pursuant to Art. 5 of the GDPR.

#### 4. Prior data protection checks of essential processes

The data protection officer will be reques-

ted if necessary, for example:

- Infrastructure enhancements
- Operation of IT solutions
- Data protection requests from athletes
- Data protection requests from employeesData protection requests

from other third parties

#### 5. Information security

The responsible body was subjected to a BSI basic protection audit and recommendations were implemented. In the reporting period, there were no relevant IT disruptions, however a breach of information security took place which was immediately investigated and logged.

## 6. Training and evidence of specialist knowledge of the data protection officer

The data protection officer Dr. Ralf Schadowski is the responsible external data protection officer. He is ISO 17024 certified in the area of data protec-tion and is therefore continuously monitored. He supports the National Anti Doping Agency of Germany with his team of 37 data protection specialists, who also have the latest training levels depending on the specialist.


#### 7. Other
